



Expression of Interest to Compete in the Tasmanian Shield Team in 2024

The Australian Junior Championship will be held at AGL National High Performance Centre on the Sunshine Coast in 2024 we are looking for expression of interest for Juniors (must be under 18 as at 1st January 2024) bowlers to compete in a Tasmanian Team.

This event gives the bowler the opportunity to compete against other bowlers from around Australia and New Zealand. The Championship is set to take place in April 2024, with President Shield being a team event.

Eligibility is open to all 2023 TBA Registered Junior Players, residing in Tasmania regardless of average. Successful President's Shield Team players are required to be TBA silver members in 2024.

If the committee receives more than 6 eligible girls and boys the Tasmanian State Junior Committee will hold a roll off with a date and venue to be advised.

PLEASE READ ADDITIONAL INFORMATION BEFORE SUBMITTING AN EXPRESSION OF INTEREST

Upon selection, team members will be required to pay all cost involved (approximately \$2,800 per athlete). This is a guide only and is based upon costs known and / or reasonably estimated at September 2023. The final cost to team members may vary as costings become more accurate.

The athlete's team fee include (but not limited to):

- Accommodation and ground travel for the event
- 1 Team Tasmanian travel shirt
- 2 President's Junior Interstate Shield shirts
- 1 pair dress skorts (girls) or 1 pair trousers (boys) (as appropriate & to comply with tournament rules)
- jacket
- Breakfast (every day)
- Lunch (during the President's Junior Interstate Shield tournament – 3 days)
- President's Junior Interstate Shield Celebration event ticket
- Team photos
- Event lineage
- airfares

By nominating the athlete agrees:

1. to be available to participate during April 2024.
2. to accept all direction from the Team Managers and Coaches and to attend and participate in all team training sessions, except for illness or injury or any circumstances granted by the Management Team.
3. that the team will travel and be accommodated together for the duration of the competition.
4. that I have read and agree to abide by the TBA Code of Ethics, TBA Social Media Policy, TBA Member Protection Policy, the TBA rules covering the tournament and the team of which I am a member. I understand and agree that if there is a breach of the code, policies or rules that I may be removed from the team and team environment at any time as determined by the team management. No refunds will be given and any expenses incurred will be at my own cost.
5. that I / we will pay monthly instalments or bills as they fall due.
6. that if for any reason I withdraw from the team, after confirmation, I will pay / forfeit any monies to TBT that have been outlaid on my behalf up to the point of withdrawal; no refunds will be given.
7. to conduct myself in a manner befitting an ambassador of TBT and the sport of Tenpin Bowling and where possible assist in public relations, promotional and other activities as requested by TBT and the Management Team.
8. to abide by the dress rules as applied by the National body in regard to their dress policy and rules.
9. that whilst travelling as a Team, my priority and commitment is to be to the Tasmanian Team and to the performance of the Team as a whole.
